Introduction

1. This circular sets out our overall funding for HEFCW-funded higher education (HE) providers in Wales for the academic year (AY) 2018/19 of £138.2m (£120.7m in 2017/18), including individual institutional allocations for research, part-time undergraduate (PT UG) and full-time undergraduate and Postgraduate Certificate in Education (FT UG/PGCE) teaching funding. The AY 2017/18 figure is £21.4m higher than that originally announced in W17/11HE - HEFCW's Funding Allocations 2017/18, mainly as a consequence of the additional funding allocations in March 2018, which resulted from the revised Financial Year (FY) 2017-18 remit letter (as detailed in paragraph 9).
2. Our grant funding does not include payments for tuition fee grants or other student support payments which the Welsh Government administer.
3. The Welsh Government allocates funding to HEFCW annually for financial years (FYs) from 1 April to 31 March. HEFCW allocates funding to HE providers for academic years (AYs) from 1 August to 31 July.

Contents

4. This circular covers all elements of our funding allocation for AY 2018/19 as set out in the annual remit letter ([remit letter FY 2018-19](#)). This includes the formula driven recurrent grants as well as the grants that are allocated subject to the provision of business or other types of plan or strategy. The overall budget and funding allocation details are presented here in Table 1 at the macro level. The capital allocations will be announced separately, as will some of the funding allocation details for strategic initiatives such as funding for Reaching Wider and funding provided from UK initiatives such as the UK Research and Public Investment Fund (UKRPIF) and the Global Challenge Research Fund (GCRF).

Structure

5. There are seven main sections in this circular:
 - Overall budget distribution AY 2018/19
 - Allocations of funds for research – Quality Research (QR) and Postgraduate Research (PGR) training allocations
 - Teaching allocations for PT and PGT - credit based, per capita and premium funding for PT UG and per capita funding for PT and FT PGT
 - Allocations for FT UG and PGCE – expensive subjects premium (ESP) and per capita funding
 - Overall teaching and research allocations by individual institution
 - Fee mitigation funding
 - PGT Masters Interim Support package

6. This circular also covers such matters as data sources, terms of grant, payment arrangements and audit, where appropriate.

Overall budget distribution AY 2018/19

Context

Financial Year (FY) 2017-18 budget revisions

7. During AY 2017/18 it was confirmed that £6.241m of additional funding would be made available in FY 2017-18 along with a corresponding reduction of the same amount in FY 2018-19. That change was included in a revised FY 2017-18 remit letter received in late January 2018. These new figures resulted in changes to the pro rata reductions in AY 2017/18 (from £28.5m to £22.5m) and to the predicted pro rata reduction in AY 2018/19 (from £8.5m to £14.5m, although additional released funds subsequently reduced this predicted requirement to £12.5m).
8. A supplementary revision to the [FY 2017-18 remit letter](#) was received in March 2018 which detailed an additional allocation of £13.6m which was being made available – £7.7m of revenue funding and £5.9m of capital funding.
9. The additional revenue funding was provided to support the following activities:
 - i) £1.8m to encourage universities to further develop activities related to their civic mission.
 - ii) £1.2m to support the involvement of Welsh universities in the establishment of an Institute of Coding, which includes £0.2m to enable civic mission activity supporting coding initiatives in schools, colleges, work-based learning providers and universities.
 - iii) £1.7m to help alleviate the impact of pressures on our budget, specifically to help sustain performing arts provision.
 - iv) £3m to improve and increase collaboration between HE and FE, as reforms are progressed in the post-compulsory education and training sector.
10. Plans for these additional funds have been released separately.
11. As a result of these changes, the funding allocation for AY 2017/18 has been revised since the funding allocations circular published in June 2017 (W17/11HE).
12. The comparative funding for AY 2017/18 included in Table 1 takes account of all the revisions above as well as changes to the FY 2018-19 budget compared to the estimates made last year.

FY 2018-19 budget

13. The FY 2018-19 budget was finalised in March 2018. The table below provides a comparison of the original FY 2017-18 remit letter funding, the January 2017 revised FY 2017-18 remit letter funding and the FY 2018-19 final budget.

Note - In addition, in FY 2017-18 £3,665,000 was provided for SLC costs to be funded from the HEFCW budget.

14. From FY 2017-18, the budget allocation is presented by the Welsh Government as one amount under a new heading of “HEFCW revenue expenditure”. This heading replaces the separate budget lines previously in place for For Our Future, HEFCW running costs and HEFCW receipts.

Derivation of AY 2018/19 budget

15. The academic year budget is calculated using a proportion of one year’s financial year budget (usually 60%) and a balancing proportion (usually 40%) of the next. The Council has applied these proportions flexibly as required in recent years to manage the impact on HE providers in Wales of significant reductions in HEFCW funding.
16. It should also be noted that, since FY 2017-18, our running costs have not been detailed separately in the Welsh Government budgets. The amount that we forecast to require for running costs in each financial year is deducted from the available resource before the academic year resource is derived.
17. The FY 2018-19 remit letter includes funding allocations for fee mitigation, PGT Masters interim support and capital funding, which have been treated as ring-fenced budgets for activity to be delivered within particular academic years. Therefore, these budgets have not been taken into account when determining the proportions of each financial year budget available to resource AY 2018/19. Instead they have been split between academic years in line with our expected expenditure profiles. This is reflected in the table below and in Table 1. These are described in more detail in paragraphs 59 to 63.
18. The FY 2019-20 budget is indicative at this stage and Welsh Government officials cannot provide any confirmation of the funding from FY 2019-20

onwards. However, the FY 2018-19 remit letter states that the expectation is that income to HEFCW will increase in each year for the lifetime of this Government. We consider our estimate of £144.76m (including £5m for fee mitigation and £5m for PGT Masters interim support) for our total budget for FY 2019-20 to be a reasonable estimate to use as a basis for allocating funding for AY 2018/19.

19. Therefore the distribution of financial year allocations to the AY 2018/19 is:

20. To this is added the current estimate for unallocated and uncommitted cash resources at the end of AY 2017/18 of £3,101,515 giving a potential total resource for AY 2018/19 of £140,621,779.

21. The table below summarises the overall funding allocations, which are set out in more detail in Tables 1 to 6.

22. The funding reduction of £12.5m (compared to £22.5m in AY 2017/18), has been calculated on a pro rata basis across credit based part-time undergraduate teaching, QR, PGR and ESP and presented as a total funding adjustment budget line. The adjustment has not been allocated against individual funding lines. This reflects the Council's view that our funding for QR, PGR, part-time undergraduate teaching and ESP are of equal strategic priority. Whilst a funding reduction has to be made, applying the funding adjustment as a one line reduction rather than an adjustment to each funding line will allow HE providers to make their own decisions as to where and how the funding reduction should be applied within their own institutions. We expect that decisions about allocations to departments and courses will be made strategically by institutions in the light of local circumstances and priorities and with due regard to the potential impact of allocations in terms of their statutory responsibilities, including for equality and diversity as well as other Welsh Government priorities.
23. This funding adjustment has been applied to the baseline allocation, which comprises the core funding allocations for research, teaching and strategic initiatives, prior to the reduction of Council budgets.
24. Based on the current assumptions of future funding available for us to allocate for FY 2019-20, we expect AY 2018/19 to be the final year that a funding reduction has to be applied.

Budget allocation

25. Table 1 provides an analysis of the total funding allocation by the main budget headings, which have been agreed for AY 2018/19.
26. The equivalent figure for AY 2017/18 is shown for all budget lines.

Allocations of funds for research

Quality Research (QR)

27. The QR component of the recurrent grant recognises the quality and volume of research, as demonstrated by the 2014 Research Excellence Framework (REF). For AY 2018/19, the funding set aside for QR is £71.077m, equivalent to the funding in the prior year, and the formula applied is the same as that which was applied in AY 2017/18.
28. We have extended, for a further year, the ring-fence on the funding previously allocated to the University of Wales Press, pending wider review of our research funding arrangements. In AY 2018/19, this funding (£132k in total) will continue to be ring-fenced within QR for the purpose of supporting scholarly publications and related activities in the fields of Welsh culture, history and literature. We will review this arrangement in the future. The ring-fenced amounts for individual institutions remain at the amounts which we notified in 2011.
29. The AY 2018/19 QR allocations are set out by institution in Table 2. A breakdown for each institution by unit of assessment (UoA) is provided in Annex A. The funding per unit volume by subject group and quality level is shown at Annex B.

Postgraduate Research Training (PGR)

30. PGR is supported outside the teaching funding method. The threshold for a UoA to be included in the calculation of PGR funding is set at the same level as QR.
31. Funding is within an overall maximum amount agreed by us each year and is based on the most recent confirmed number of actual enrolments. These are the eligible, fundable enrolments in UoAs which qualify for QR funding in AY 2018/19. The enrolment data are taken from the Higher Education Statistics Agency (HESA) student record returns for AY 2016/17.
32. For AY 2018/19, the Council set the overall maximum amount of funding for PGR, maintaining the AY 2017/18 cash level of £5.17m. Not all PGR students can necessarily be funded with the funds available. Where the

funding allocated to institutions on the basis of the standard units of funding would exceed the total available, allocations are reduced on a pro rata basis. The PGR allocations are set out in Table 3.

Funding for teaching Part-time Undergraduate (PT UG) and Postgraduate Taught (PGT)

33. We are continuing to fund PT UG in AY 2018/19 through the credit based teaching funding method, plus premiums and per capita funding, used in AY 2017/18, but, as was the case in AY 2017/18, there will not be any PGT credit based teaching or premium funding. In AY 2018/19, for PT and FT PGT provision, we will only provide per capita funding being a payment of £5 per postgraduate taught student.

Teaching allocations – PT UG only

34. Funds for PT UG teaching have been determined using our teaching funding method. This is described in detail in HEFCW circular W99/71HE, dated 30 July 1999. HEFCW circular W01/66HE, dated 3 August 2001, sets out the arrangements and procedures under which funding by credit value operates. A change was made in AY 2011/12 with the removal of the recovery element of the method.

Funding cells

35. Funding allocations are based on funding cells. A funding cell refers to a particular:
- a. *level*: undergraduate (not franchised-out); undergraduate franchised out;
 - b. *mode*: part-time;
 - c. *academic subject category (ASC)*: ASCs 1a to 11b and ASC 11a, Initial Teacher Training (ITT) leading to Qualified Teacher Status (QTS), split into Primary and Secondary.

Academic subject categories

36. Funding in each cell is established by multiplying the number of credit values funded in that cell by our standard unit of funding for the ASC.
37. The standard units of funding per credit value for each ASC for PT UG in AY 2018/19 are the same as those used in AY 2017/18. These are set out in Annex C.

Allocations of teaching funding and funded credit values

38. Total PT UG funding and funded credit value allocations in each cell are shown in Annex D.
39. The PT UG core numbers are determined by the funding model. They are calculated by using funded credits from AY 2017/18 and allocating them to funding cells using both the distribution of funded numbers for AY 2017/18 and recruitment for AY 2016/17 taken from the end of year monitoring (EYM) data extracted from the HESA student record. This process is described in more detail in the circular referenced in paragraph 34.
40. The initial run of the AY 2018/19 teaching model revealed that reduced recruitment in some areas would result in a reduced PT UG allocation in AY 2018/19, compared to AY 2017/18. However, given that some institutions would still have some unfunded (“fees only”) provision, this seemed inappropriate.
41. Therefore, in view of the decline in part-time numbers and the current challenges faced by HE providers in Wales in recruiting part-time undergraduates, all fees only credits will be converted into funded credits, thereby supporting those institutions that are able to recruit. This means growth in funded credits in some institutions, which is included in Annex D. Table 4a shows the breakdown between core funded credits and funding, and growth funded credits and funding.
42. We will provide funding only for the number of credits set out in Annex D to this circular; numbers above the funded numbers will attract only the appropriate fee. The Welsh Government had previously made clear that it does not wish to see significant real-terms increases in part-time fee levels. As indicated previously we plan to undertake a more fundamental review in the light of the outcomes of Professor Sir Ian Diamond’s independent review of higher education funding and student finance arrangements.

Per capita – PT UG and all PGT provision

43. The per capita amount for AY 2018/19 has been set at a rate of £5 per student. Payments have been determined on the basis of fundable enrolments according to AY 2016/17 HESA student record data, subject to the minimum 10 credit value study requirement. The amount of per capita funding allocated to each institution is shown in Table 4a.

Part-time fee waiver

44. Our part-time undergraduate fee waiver scheme offers grants to providers that waive fees for part-time undergraduate students studying fewer than 30 credits (i.e. below 25% full time equivalent) who are unemployed and registered jobseekers or are in receipt of Department for Work and Pensions (DWP) benefits. The figure quoted in Table 1 represents an estimate at this stage of the expected call on this budget.

Premiums - PT UG

45. Table 4b sets out the PT UG individual allocations for the Access and Retention premium, the Welsh Medium premium and the Disability premium.
46. Each premium is described below.
 - a. *Disability Premium* - A rate of funding allocated per eligible student, which are those students recorded as in receipt of the Disabled Students' Allowance on the HESA student record, and are subject to the minimum 10 credit value study requirement (or 8.3 % FTE for PGR students). In AY 2018/19 for PT UG students the rate will be £300, the same as that available in AY 2017/18. The allocations are set out in Table 4b. Also included in Table 4b are the disability premium allocations for PGR.
 - b. *Welsh Medium Premium* - The Welsh Medium premium adds a weighting of 0.34 to the AY 2018/19 unit of funding for modules undertaken through the medium of Welsh. The allocations to each institution, based on the average of AY 2015/16 and AY 2016/17 HESA credit value data, or in the case of FE institutions for AY 2015/16, returns made directly to us, are set out in Table 4b.
 - c. *Access and Retention Premium* - There are two elements to the Access and Retention premium allocations for part-time undergraduate provision. A premium is awarded in respect of students from areas of low participation in higher education and students from Communities First clusters. Individual students may attract more than one premium.

In order to reward retention, we have allocated a higher rate of funding with respect to continuing students than to students in their first year. The higher rate is also allocated with respect to students on one year courses who complete or partially complete.

To recognise that the proportion of widening access students within an institution impacts on the extent of support required, institutions have been separated into two bands depending on their recruitment in AY 2016/17 from Communities First areas. Institutions where students from Communities First areas represent more than 15 per

cent of Welsh domiciled students are in band 1 and receive a higher premium, and those where students from Communities First areas represent 15 per cent or less are in band 2 and receive a lower premium.

For AY 2018/19, we will maintain the level of Access and Retention premium at the AY 2017/18 levels. Individual allocations are detailed in Table 4b.

Total PT and PGT funding allocations

47. Table 4a shows both funded credit numbers and associated funding for PT UG teaching, premiums and per capita, and funding for PT and FT PGT per capita.

Allocations for Full-time Undergraduate (FT UG) and PGCE

48. As for AY 2017/18, the higher rates of Expensive Subject Premium (ESP) are the only funding premiums being allocated for FT UG/PGCE. These are allocated in respect of Clinical Medicine/Dentistry and Conservatoire Performance Element provision.
49. The ESP will be retained at the AY 2017/18 level. The allocations are outlined in Table 5 and have been based on the two premium rates below, awarded per completed credit value –
- Expensive subjects premium:*
- a. Rate 1 - £80, applied to clinical medical/dentistry subjects (equivalent to academic subject categories (ASCs) 1b and 1d)
 - b. Rate 2 - £30, applied to Conservatoire Performance Element (Performance Element provision in ASC 10)
50. In addition, as was the case in AY 2017/18, in AY 2018/19 provision for ESP will be capped by limiting the number of credit values that can be used in the calculation. For Clinical Medicine and Dentistry, this is the credit values equivalent to the number of quota clinical places, and for Conservatoire provision, credit values equivalent to the funded student number that was agreed as part of the special funding arrangement in place, prior the introduction of the revised tuition fee regime in AY 2012/13.
51. Also, to ensure funding at some level for all students, the per capita element of the current funding method has been maintained for all FT UG/PGCE students, at the level of £5 per student.

Overall research, PT UG teaching and FT UG/PCGE funding allocations

52. Table 6 sets out the allocations to each institution for teaching and research funding and provides a comparison with the funding allocations in AY 2017/18. It includes an amount of pro rata funding reduction, in each year, attributable to each institution. However, as previously stated, although that pro rata adjustment has been calculated pro rata on teaching, QR, PGR, and ESP allocations, institutions are not required to replicate our approach when making their own internal adjustments.
53. The AY 2018/19 figures in Table 6 do not include details of the £10m fee mitigation funding or PGT Masters Interim support. These allocations are provided in Table 7 and 8.
54. These allocations do not take account of any potential in-year funding adjustments for FY 2018-19 that may be applied by Welsh Government. Any such funding adjustments will result in a revision to the individual allocations. In addition, if the FY 2019-20 allocation is different to the amount assumed for this allocation, there will be an impact on the resource available in AY 2018/19 and the associated allocations.
55. In order to facilitate some flexibility and collaboration, institutions are offered the opportunity to redistribute PT UG funded credits between institutions on a cost neutral basis. Should providers wish to exercise this option, they should jointly inform us of their intentions by the end of July 2018.

OU Mitigation funding

56. Since AY 2013/14, the Council has given special consideration in determining the overall funding allocations to the OU in Wales. In the light of the budget changes following the introduction in AY 2012/13 of fees of up to £9,000 for FT UG/PGCE, Council recognises that the OU has no FT UG/PGCE fee income to potentially offset any reductions in the other budget lines. As a result, we monitor the overall impact on the OU and make an adjustment to compensate for their inability to replace strategy funding with FT UG/PGCE fee income, and to compensate for the loss of PT premium funding.
57. In AY 2017/18, repeating what was done in previous years, we awarded the OU a one-off payment, essentially to the value of the strategy funding they have lost, the equivalent amount of funding that they would have received in AY 2015/16 for the PT premium had we not removed it, and the amount of PT PGT core teaching funding that the OU received in AY 2015/16 prior to the removal of that funding. We will be providing the same amount of additional funding to the OU in AY 2018/19 (£1.655m). In addition we are still committed to monitoring the OU in Wales fees only position, and have put in place a process where, at the end of an academic year, we will use the EYM data to determine the actual delivery

of any fees only unfunded provision. As an incentive to continue to grow PT provision, depending on affordability, we have previously committed to allocate credit values and funding to cover the fees only element where they have recruited more than their funded credit values, up to the value of their 2013/14 funded credits. This has been addressed in AY 2018/19 by the conversion of all fundable fee only credits in the system to funded credits (paragraph 41 refers).

58. Table 6 includes the mitigation funding for the OU.

Fee mitigation funds

59. The Cabinet Secretary's October statement included confirmation of an additional £10m of funding for HE providers in Wales to deal with immediate issues arising from not being able to increase FT UG/PGCE tuition fees above £9,000 in AY 2018/19. £5m of this funding has been allocated to us in the FY 2018-19 remit letter with a further £5m expected in FY 2019-20. This is included as income and expenditure in Table 1.
60. The allocations for the fee mitigation funding have been calculated pro rata to the total FT undergraduate/PGCE completions taken from the HESA 2016/17 student record data. A condition of funding related to 17% of this funding will be attached to the funding relating to the Reaching Wider Programme activity. A HEFCW Reaching Wider consultation seminar (18 May) discussed these proposals and more detailed information will be available in due course. The allocations for the fee mitigation funding are provided in Table 7.

PGT Masters Interim Support AY 2018/19 (and continuing PT in 2019/20)

61. In January 2018, we published circular [W18/01HE](#), which provides details of our interim PGT Masters support package for students ordinarily resident in Wales and EU students, attending Welsh HE providers in academic year AY 2018/19. This scheme will be delivered by us for a single year prior to the implementation by the Student Loans Company (SLC) of the Welsh Government's PGT support package in AY 2019/20.
62. The circular provides the background to the scheme and outlined the sector consultation and how the scheme was designed to address the issues that were identified by providers. It also includes the method of allocation to institutions. The providers have the discretion on how the funding is distributed, as long as any awards are given only to those students eligible for loans set out in the [2017/18 Postgraduate Masters Degree Loans regulations](#).
63. The allocations for the PGT Interim support for AY 2018/19 (and continuing PT in 2019/20) are provided at Table 8.

Terms and payment of grant, data sources and audit

Terms of grant

64. The basis on which PT UG teaching funding, per capita, FT UG/PGCE and research funding is being provided to HE institutions is set out in the Annual Schedule to the Memorandum of Assurance and Accountability between us and individual institutions, and will reflect the latest Welsh Government conditions of funding as set out in our FY 2018-19 remit letter. For FE institutions, it is set out in their Annual Funding Agreement. The Funding Agreements for AY 2018/19 will be issued by November 2018 and will specify the arrangements for adjustment of funding where institutions fail to achieve the PT UG numbers for which they have been funded.
65. There will be a leeway of 1% for under-recruitment on the total funded numbers for PT credit based funding. As in prior years, funding adjustments for AY 2018/19 amounting to a threshold of the lesser of £50,000 or 10% of the total teaching allocations will be regarded as *de minimis* and not applied. If a funding adjustment is applied, the threshold will be deducted from the adjustment amount.
66. **It should be noted that institutions are not required to replicate our approach to establishing allocations when making their own internal allocations. We expect that decisions on detailed resource allocations to departments and courses will be made strategically by institutions in the light of local circumstances and priorities and with due regard to the potential impact of allocations in terms of their statutory responsibilities, including for equality and diversity, as well as other Welsh Government priorities.**

Data sources

67. The data used for funding have been provided and checked by institutions.
68. The data for funded credit based funding for teaching have been taken from EYM data extracted from the HESA student record for AY 2016/17.
69. Per capita allocations and premium allocations have been based on HESA 2016/17 student record data.
70. Welsh medium premium allocations have been based on the average of the AY 2015/16 and AY 2016/17 HESA credit value data. For FE institutions, for 2015/16, data have been provided to HEFCW directly by the institutions concerned.
71. Funding allocations for PGR have been based on AY 2016/17 HESA data.
72. The data for funding for research have been taken from the returns to, and the outcomes of, the 2014 REF. In addition, minor volume measures data

about research assistants and research students have been taken from the 2013/14 HESA staff and student records respectively.

Payment of grant

73. Our initial payment profile assumptions in AY 2017/18 were changed as a result of the in year budget changes and subsequent pro rata adjustment. This ensured that the institutions were paid as much of their recurrent funds prior to the end of March 2018 as possible. In AY 2018/19, our initial payment profile proposals are detailed in the table below.

74. Should there be budget changes or cash management constraints (e.g. HEFCW's carry forward limit from one FY to the next) we may require this profile to be adjusted in-year.

Audit of data and quality

75. The allocations of funds for teaching, FT UG/PGCE, PGR and QR are established by applying our funding methods to data supplied by institutions. Data provided by institutions and used for funding purposes are subject to audit. Details of the current process of audit can be found in circular *W14/11HE Audit of Higher Education Data 2014/15 to 2017/18*. The process to take place for 2018/19 will be published later in 2018.
76. Where, as a result of audit, we find that the data on which allocations have been based have resulted in any institution receiving an allocation larger than it is due, the funding for the institution concerned may be adjusted.
77. Our procedures for addressing unsatisfactory quality in institutions in Wales (circular W16/05HE) reports on actions we will take where regulated institutions demonstrate quality which is, or is likely to become, inadequate prior to the initiation of statutory intervention. It aims to ensure that the interests of students, the provider and the wider higher education sector are protected.
