Introduction

1. This circular provides a consultation on procedures for quality that is, or is likely to become, inadequate¹.

Background

2. The [Higher Education \(Wales\) Act 2015](#) (the 2015 Act) sets out interventions that apply where HEFCW is satisfied that the quality of education provided by or on behalf of a regulated institution is (likely to become) inadequate. These are detailed in HEFCW's [Statement of Intervention](#).
3. The Quality Assessment Framework for Wales was published as part of HEFCW [circular W18/05HE](#).

Quality that is (likely to become) inadequate

4. This circular provides a consultation on additional guidance relating to quality that is (likely to become) inadequate. This supplements the information provided in the Quality Assessment Framework, and covers the mechanisms HEFCW will use to determine whether provision is (likely to become) inadequate, as well as the procedures prior to the initiation of the Statement of Intervention. The guidance is available at **Annex A**.

Consultation questions

Question 1: Are the mechanisms that HEFCW proposes to use to determine whether provision is (or is likely to become) inadequate appropriate? Are there any other mechanisms that HEFCW should use?

Question 2: Are the actions HEFCW proposes to undertake prior to implementing the Statement of Intervention appropriate? Are there any other actions which HEFCW should undertake?

Question 3: Are there any unintended consequences of the proposed procedures for quality that is, or is likely to become, inadequate?

Question 4: Are there any gaps in the procedures? If so, please provide further detail.

Question 4: Do the proposals have any positive or negative impacts or unintended consequences in terms of equality and diversity and the Well-Being of Future Generations (Wales) Act's seven

wellbeing goals, sustainable development principle and five ways of working?

Question 5: What effect will the policy have on opportunities for persons to use the Welsh language and treating the Welsh language no less favourably than the English language? How could the policy be changed so that the policy decision would have (increased) positive effects on opportunities for persons to use the Welsh language and treating the Welsh language no less favourably than the English language, and fewer or no adverse effects?
